CAMPER and PARENT/GUARDIAN (“CAMPER”) acknowledge and declare and agree as follows:

1. CAMPER voluntarily agrees to participate in the programs, facilities, and services of the Tourette Syndrome Camping Organization (“TSCO”), a charitable and benevolent corporation under the General Not for Profit Corporation Act of 1986 in the State of Illinois, “the Program” From Sunday, June 24, 2012 till Saturday, June 30, 2012 and in consideration of being permitted use of these facilities and participation in this Program, do voluntarily execute this “Release and Assumption of Risk” on behalf of CAMPER, CAMPER’s heirs and next-of-kin, personal representatives and estate.
2. CAMPER has been fully informed of the nature, scope and demands of the Program, and understands that the Program may include activities which could be dangerous to CAMPER and other participants and which could cause property damage and/or bodily injury.
3. TSCO has informed CAMPER that there may be dangers and hazards inherent to participants in the Program because of the activities involved and that CAMPER recognizes and appreciates that such dangers and hazards exist, and that CAMPER may sit out any activity that he/she believes to be too dangerous and/or too risky after advising a member of the TSCO staff of CAMPER’s concerns. CAMPER accepts and assumes full responsibility for all harm and injury, of every nature, which may occur to CAMPER or that CAMPER may suffer or cause to others, and for all damages or loss to any personal property owned by CAMPER or damaged by CAMPER, while CAMPER participates in the Program and during all travel and transportation, and, in furtherance thereof, CAMPER agrees to indemnify, hold harmless and release TSCO, its agents, officer, volunteers, employees, representatives, successors, assigns, subcontractors, and independent contractors (including but not limited to all individuals who may provide accident, rescue and/or medical treatment for CAMPER) their heirs, representatives, successors, and assigns individually and collectively, “RELEASEES”) from and against any and all claims, demands, actions or causes of action, on account of damage or loss to CAMPER’s personal property, personal injury, or the bodily injury or damage to personal property of others caused by CAMPER, which may occur or result directly or indirectly from CAMPER participation in the program and not as a direct result of any negligent act of the TSCO or RELEASEES.

4. CAMPER declares that he/she is able to physically withstand and cope with the disclosed rigors of the Program with or without a reasonable accommodation. If an accommodation is needed, CAMPER will contact TSCO in advance of CAMPER participation.

5. This "Release and Assumption of Risk" shall be construed and interpreted pursuant to the laws of the State of Illinois, and if any portion thereof is held invalid, void, unenforceable or illegal, the remainder shall continue in full force and effect.

6. CAMPER acknowledges that TSCO does not provide accident/health insurance for CAMPER. The undersigned PARENT/GUARDIAN agrees to assume personal and financial responsibility for any medical care and treatment.

CAMPER declares that he/she completely understands and has fully informed himself/herself of the terms and conditions of this "Release and Assumption of Risk" by having read it, or having it read to me, before signing with an electronic signature, and CAMPER intends to be fully bound thereby:
