**WAIVER AND RELEASE OF LIABILITY BY CAMPER
AND PARENT/GUARDIAN AND COVENANT NOT TO SUE**

For and in consideration of the acceptance of CAMPER with Tourette Syndrome Camping Organization ("TSCO"), organized as a charitable and benevolent corporation under the General Not For Profit Corporation Act of 1986 in the State of Illinois, the undersigned CAMPER and PARENT/GUARDIAN each irrevocably waives, releases, and discharges, for ourselves, our heirs, executors, administrators and assigns (individually and collectively, our "Representatives"), TSCO and/or TSCO's agents, officers, employees, representatives, successors, assigns, subcontractors, and independent contractors (including but not limited to all physicians, nurses, emergency medical technicians, and all other medical personnel who may provide accident, rescue and/or medical treatment to or for CAMPER), their heirs, representatives, successors and assigns (individually and collectively, "TSCO's RELEASEES") from any and all actions, causes of action, claims, demands, injuries, damages, property loss, costs, loss of services, expenses, compensation, and all consequential damage of whatever nature which CAMPER may incur or sustain arising out of CAMPER's attendance and participation as a camper with TSCO, including transportation to or from TSCO.

CAMPER and PARENT/GUARDIAN further agree, on behalf of ourselves and our Representatives, not to sue TSCO and/or TSCO's RELEASEES in any forum for any such injury, loss or damage that CAMPER may incur or sustain arising out of CAMPER's attendance and participation as a camper with TSCO, including transportation to or from TSCO.

CAMPER and PARENT/GUARDIAN understand that TSCO does not provide accident/health insurance for CAMPER, and thereby agree to assume personal and financial responsibility for any such medical care and treatment.

CAMPER and PARENT/GUARDIAN each further state we have read the foregoing Assumption of Liability by Camper and Covenant Not To Sue prior to its execution and that we understand its contents.

In addition to the above, PARENT/GUARDIAN of CAMPER further agrees to indemnify, defend and hold forever harmless TSCO and/or TSCO's RELEASEES from and against any and all demands, claims, actions or causes of action, losses, costs, damages or expenses (including reasonable attorney fees) brought by CAMPER and/or his Representatives against TSCO and/or TSCO's RELEASEES that is within the scope of this Release and Waiver of Liability by Camper and Covenant Not to Sue.

In the event of any claims or litigation arising out of or in connection with any activity by CAMPER at TSCO, including transportation to or from TSCO, CAMPER and PARENT/GUARDIAN hereby agree that the venue for any dispute, controversy, cause of action, lawsuit or claim arising out of or in connection with CAMPER's attendance and participation at TSCO, including transportation to or from TSCO, shall be settled by the courts of the State of Illinois, Cook County, which shall have exclusive jurisdiction over every party in connection with any such dispute, controversy, cause of action, lawsuit or claim.

If any part of this Agreement is declared to be unenforceable, then the remaining terms shall continue to be in full force and effect.
